### **3.2.4** NEW CONTEMPORARIES

A virtual presentation of the works selected by Alexandre da Cunha, Anthea Hamilton, and Linder for the 2020 Bloomberg New Contemporaries was presented by Kirsty Ogg and Seamus McCormack of New Contemporaries on 19 June. The GAC has agreed to confirm our interest in works after seeing them and they will be shown to the Committee for approval at the March meeting.

# 5. TenTen print project

The Committee was informed that on Tuesday 6 October 2020 a virtual reception was hosted to announce the artist and unveil the print live from the Foreign, Commonwealth and Development Office. The event included a welcome by the GAC Director; introduction from Caroline Dineage, the Minister for Digital and Culture; the 2020 artist, Yinka Shonibare; the sponsors, Sybil and Matthew Robson Orr; and final thanks from Candida Gertler, Director of Outset Contemporary Fund. It was broadcast live on YouTube with a virtual audience of approximately 100 people. A number of journalists were present who, after the launch, interviewed Yinka Shonibare. A short video was also launched on the GAC website showing the process of making the print at the printer's studio.
